- All members of the public are welcome to attend, but only property owners registered as members of the Company will be entitled to vote on resolutions presented at the AGM.
- Membership of the Company is free of charge to all rateable property owners in the SRA. An
 application form is available on the Company's website or at the SRA's office. Owners wishing
 to apply for membership should complete the registration form and return it by e-mail or
 hand delivery to the SRA office. New membership applications must be received by no later
 than 24 October 2017 to be approved at a meeting of the board prior to the AGM.
- Any member may appoint a proxy to attend the AGM and vote on his/her behalf. In the event
 that a property owner is unable to attend the AGM, kindly complete the proxy form available on
 www.kalkbaystjamessra.org or at the SRA office which needs to be completed and returned to
 the SRA, either as an attachment to an e-mail or by delivery to the SRA office, no later than 24
 hours before the AGM. A proxy need not be a member of the Company. Members and proxies
 will be required to provide satisfactory identification to verify their right to vote at the meeting.
- Per clause 11.9.2 of the Memorandum of Incorporation, no member who is in arrears with
 payment of the additional rate for more than 60 (sixty) days, shall be entitled to vote at a
 members' meeting for so long as the member is in arrears, except if the member can prove
 that he/she is in a dispute or has entered into an appropriate payment arrangement with
 the City.
- Clause 12.1.7 of the MOI states "As required by item 5(1)(b) of Schedule 1 to the Act, at least 1/3 (one third) of the directors shall resign every year at the AGM, but shall be eligible for re-election." Tony Trimmel, Graham Durrant and Joanne McGilvray will resign. They have all made themselves available for re-election as directors. Forms for nomination of directors may be downloaded from the website or be requested by email. Nominations of any new directors are requested to be received by 3 November 2017.
