 member can prove that he/she is in a dispute or has entered into an appropriate
 payment arrangement with the City.
- Clause 12.1.7 of the MOI states "As required by item 5(1)(b) of Schedule 1 to the Act, at least 1/3 (one third) of the directors shall resign every year at the AGM, but shall be eligible for re-election." Andrew Jones, Kenneth McClarty and Andy Paige will resign. They have all made themselves available for re-election as directors. In compliance with regulations promulgated by the Government on 18 and 20 September 2020 under the Disaster Management Act the following rules will apply to the AGM to be held on 26 October 2020:

- The Community Hall will be sanitized on the day of the meeting and hand sanitizer spray will be provided for compulsory use by attendees prior to entering the Community Hall.
- All attendees will be required to wear a face mask when entering the Community Hall and at all times during the meeting.
- All attendees must maintain a distance of least one and a half meters from each other at all times.
- Attendance is limited to no more than 50% of the capacity of the hall. In order to ensure compliance with the personal safety distance of 1.5 meters and provide for attendance by City and Law Enforcement officers, attendance by members, residents and businesses is limited to 40 people.
